United Nations chief pledges to promote LGBT ‘rights’ against worldwide ‘bias’

Antonio Guterres, Family, Gender Confusion, Homosexuality, LGBT, Michelle Bachelet, Religious Freedom, Transgenderism, United Nations, Universal Declaration Of Human Rights New York, New York, September 27, 2018 (LifeSiteNews) – The secretary general of the United Nations called Tuesday for the international body to “redouble” its efforts to support the “LGBTI community” around the world.

“The United Nations stands up for the rights of the LGBTI community,” Antonio Guterres said in a message to a ministerial meeting of the UN’s LGBTI Core Group. “Many of its members are imprisoned, abused and even killed simply for who they are or whom they love.” He praised recent developments such as the Supreme Court of India ruling earlier this month that the nation’s 150-year-old sodomy ban was unconstitutional, which pro-homosexual activists hoped would promote a broader trend in the region.

“But so long as people face criminalization, bias and violence based on their sexual orientation, gender identity or sex characteristics,” he added, “we must redouble our efforts to end these violations.”

Guterres concluded his message with a promise

"that the United Nations will never give up the fight until everyone can live free and equal in dignity and rights."

UN High Commissioner for Human Rights Michelle Bachelet also called on the UN to "defend and protect" homosexuals and gender-confused people from "every" kind of "discrimination," according to the pro-LGBT *PinkNews*.

The meeting was timed to coincide with the 70th anniversary of the UN's Universal Declaration of Human Rights. Article 16 of the document affirms that the "family is the natural and fundamental group unit of society and is entitled to protection by society and the State," though in recent years the UN has omitted the phrase from agreements, and has been reluctant to define "family." "It's great, as we've been waiting to get something longer and more substantial than just a response to a couple of questions that he's had before," Maria Sjödín, deputy executive director of the pro-LGBT group OutRight Action International, told *Reuters* in praise of Guterres' speech. "It's really important not to backslide and to ensure that the human rights of LGBTI people continue to be a priority for the U.N. and the secretary general."

The secretary general's remarks placing undefined "bias" on the same plane as literal violence against homosexuals align with conservatives' objection that pro-LGBT activists use LGBT "rights" as a pretext for goals such as redefining marriage and silencing any disagreement with homosexuality or recognition of differences between the natural family and same-sex unions.

The UN has a long record of promoting the LGBT agenda in ways that go far beyond human rights, such as calling for elementary school children to be taught "non-judgmental and accurate information on sexual orientation and gender identity/expression"; promoting social acceptance of homosexuality and legal recognition of perceived "gender identity"; imposing same-sex "marriage" on countries; and prohibiting treatment for unwanted sexual attraction.

"Freedom of expression and expression of religion" are "not absolute" rights, UN Independent Expert on sexual orientation and gender identity Vitit Muntarbhorn said last year, and can be curtailed if doing so is deemed necessary.

Eulogy for Jeremiah (Jerry) Maloney

St. Thomas More Church
Centennial, Colorado
September 17, 2018

Jeremiah Maloney was born in Beachview, Pennsylvania, on January 29, 1935. His grandparents were Irish immigrants, a heredity which entitled him to lay claim on all things Irish. He had two older sisters, Betty who survives him and another sister who died when she was two years old. Jeremiah grew up in the Pittsburgh area. His father passed away when Jeremiah was in his early twenties, and he was forced to leave college where he was studying theology, to support his mother and sister. When he was no longer needed by his family, he became a student at the Catholic University of America, Washington, D.C. and earned a PHD in Clinical Psychology. Following graduation, Jeremiah taught Education and Psychology

at Mount Carmel College in Niagara Falls, Ontario, where he is remembered as a beloved teacher, counselor, and mentor to scores of college students. Later he taught at Georgetown University and Bonaventure University and worked on staff as a clinical psychologist at St. Elizabeth's Hospital, Washington, D.C.

Jeremiah was a dog lover. One of his most memorable pooches was a char-pei who rode in the passenger seat of his car throughout the Washington area.

Eventually, Jeremiah's career took a new route. For seven years he was the acting director of the Peace Corps in Malaysia, Nepal, Samoa, Macedonia and Haiti. Later, he began a career in government service working for the Department of Human Services in the North Eastern United States. Jeremiah spent twenty-five years traveling throughout the world to help deliver health care services to impoverished countries. He made lifetime friends wherever he went. His was an enduring passion for the underserved and he worked tirelessly for civil rights. Importantly, he helped to draft The Americans With Disabilities Act.

Following his retirement from government service, at age sixty-six, Jeremiah literally jumped into a new career in aquatic fitness. In four short years, at age seventy, he acquired stellar credentials and growing respect for his contribution to the sport. He gained an excellent reputation as a dependable full time instructor. When he attended his first International Aquatic Fitness Conference, he was dubbed the "world's oldest pool boy" for helping set-up equipment for pool demonstrations. Jeremiah's primary motivation was to help reduce the ranks of unfit, frail, elderly adults. His favorite stories of personal fulfillment came from a ground breaking, twice a week class titled "MS and More" which he designed for participants diagnosed with Multiple Sclerosis and other debilitating lower extremity diseases.

In the early 1960's Jeremiah became a professed member of the Lay Carmelites of the Ancient Observance. From that time on, whenever he traveled on long plane rides he brought along and studied books on our Carmelite Saints and Carmelite Spirituality. Although he had hoped to retire

to Taos, New Mexico, his sister became ill and he came to Denver to assist her. Because there were no O' Carm. Communities available, he began visiting our Displaced Carmelite Secular Order Community, and entered formation with his characteristic vigorous enthusiasm. He was clearly well read in all things Carmelite and blessed his classmates with impromptu, delightful discussion. St. Teresa of Jesus, holy foundress of the Displaced Carmelite Order and a Doctor of the Church, instructed that detachment, humility and love of neighbor are the foundation of prayer. Jeremiah exemplified these virtues throughout his life: For instance, he willingly left college after his father's death to support his mother and sister.

Towards the end of his life, when he found out that his grandniece had been born with a congenital heart defect, he made a selfless and life changing contribution to insure her care.

As a part time Uber driver, he assisted intoxicated passengers in getting home regardless of their ability to pay.

In spite of his illness, he continued to teach Aerobic Fitness Classes. On the day before he was hospitalized he was instructing from pool side, and experienced a weak spell from which he never returned.

When Jeremiah received the diagnosis that medical science could not prevent the spread of his cancer, he was placed on palliative care and called me immediately to request completion of his formation. Having never been sick a day of his life, nor taken any medication, he told me, that he knew that "suffering would come his way one day." He continued, "I want to suffer and wake up in Christ's arms." Consoled by a Community novena to St. John of the Cross, whom Jeremiah referred to as "his lifetime companion in prayer" and the profession of his Definitive Promise, Jeremiah moved peacefully onward to enter eternal life on September 6th. Truly, Carmel was the thread woven throughout his final days.

Jeremiah was a devoted son, brother, uncle, friend and Carmelite. May he rest in the company of St. John of the Cross in Christ's loving arms forever.

Let Me Finish

The Proverbial Question: *“Why does time feel like it goes so much faster as we age”*

If it feels like all you did was blink at Christmas, and darn here we are in November starting to think about Christmas already, you'll probably be contemplating why time feels like it goes by at lightning speed the older you get.

It turns out you're not just imagining it. There are some actual scientific theories as to why we perceive time to go much faster as we get older.

The theory goes that the older we get, the more familiar we become with our surroundings. We don't notice the detailed environments of our homes and workplaces.

Because, to children, the world is still new and generally unfamiliar so they use more brain power to consume what's around them. The theory suggests that this appears to make time run more slowly for children than adults stuck in a routine.

This theory is also backed up by biology. It's thought that the more a person is stimulated by their surroundings (i.e. not familiar with their everyday routine as we become when we're adults), they release the “happy hormone” dopamine. When we reach the age of 20, dopamine levels begin to drop, and continue to do so as we age, which also contributes to time being perceived as moving faster.

There's one other theory that may explain why time appears to speed by the older we get and it's all about percentages.

The idea is that we perceive a period of time as the proportion of time we have already lived through.

Example: To a 2 year old, a year is half of their life, which is why it seems such an extraordinary long period of time to wait between birthdays when you are young.

To a 10-year-old, a year is only 10% of their life, (making for a slightly more tolerable wait).

To a 20-year-old, it is only 5%.

For a 20-year-old to experience the same proportional increase in age that a 2-year-old experiences between birthdays (for example, half their life), they would have to wait until they turn 30. Given this view point it's not surprising that time appears to accelerate as we grow older.

A philosophical point: The five-year period you experienced between the ages of 5 and 10 could feel just as long as the period between the ages of 40 and 80.

And now you know why it seems like just yesterday!
